The use of face coverings	<ul style="list-style-type: none"> <li>• The use of face coverings will be expected and encouraged in corridors and communal areas for staff and visitors where social distancing cannot be maintained.</li> </ul> <p>Where local restrictions apply</p> <ul style="list-style-type: none"> <li>• When an area moves to Local COVID Alert Level: high or very high, face coverings must be worn by adults and pupils when moving around the premises, outside of classrooms, such as in corridors and communal areas where social distancing cannot easily be maintained.</li> <li>• In the event of new local restrictions being agreed, we will communicate quickly and clearly to staff, parents and pupils that the new arrangements require the use of face coverings in certain circumstances.</li> <li>• Exemptions; Some individuals are exempt from wearing face coverings. This applies to; those who cannot put on, wear or remove a face covering because of a physical or mental illness or impairment or disability; speak to or provide assistance to someone who relies on lip reading, clear sound or facial expression to communicate.</li> </ul>	<p>Students will now only be expected to wear facemasks whilst on transport as per the current government guidance.</p> <p>Staff are expected to wear facemasks in corridors and when in social situations where social distancing rules cannot be followed. Staff are not expected to wear facemasks in classrooms as per the government guidance.</p>

Smaller rooms to comply with social distancing and safe working practice	<p><i>The majority of rooms at OTEs are large and provide plenty of space, most of them having ventilation.</i></p> <ul style="list-style-type: none"> <li>• The number of pupils and staff in smaller rooms will be closely monitored</li> <li>• Chairs will be removed / placed apart</li> <li>• Desks will be forward facing where possible</li> </ul>

Management of waste	<ul style="list-style-type: none"> <li>• There is a lidded pedal bin in each classroom and area of the school</li> <li>• Bins are double bagged when emptied</li> <li>• Bins are emptied throughout the day if full</li> <li>• All bins are emptied daily</li> <li>• Testing materials are disposed of in accordance with government guidance and advice and yellow bin liners are used for clinical waste.</li> </ul>	Staff must inform JT if they do not have a bin in their room.

Staff with sinks in their classrooms will be encouraged to get students to use them.</li> </ul>

Staff measures to reduce contact and transmission	<ul style="list-style-type: none"> <li>• Each staff member is responsible for following Covid-19 related guidance, including the use of face coverings</li> <li>• It is a requirement for staff displaying Covid symptoms that they do not attend work</li> <li>• If a staff member lives with a family member who is displaying symptoms they should not attend work</li> <li>• If a staff member is contacted by Track and Track and told to self-isolate they should not attend work</li> <li>• Each staff member is responsible for keeping 2m ideally, or 1m, from anyone</li> <li>• Hot desking will be avoided where possible</li> <li>• Office spaces and staff rooms are arranged to support social distancing</li> <li>• Staff meetings are held in a socially distanced way and will be available for staff to attend by video conferencing</li> <li>• Staff are able to leave site early to complete paperwork at home</li> </ul>	Staff reminded on regular basis

Insufficient staff capacity to deal with numbers of pupils - Shortage of teachers to maintain staff to pupil ratios	<ul style="list-style-type: none"> <li>• School Closure Policy to be followed; consideration to the following will be given: <ul style="list-style-type: none"> <li>○ Can the school timetable can be modified to utilise the skills of staff available for the school to remain partially open;</li> <li>○ Could a reduction in pupil numbers could allow for the school to remain open;</li> </ul> </li> </ul> <p>If operation cannot be achieved, the agreement of the Governing Body will be sought to, close or partially close the school. Possible symptoms of Covid-19	<ul style="list-style-type: none"> <li>• Staff check with pupils regarding symptoms on their arrival at school, including temperature taking with a non-contact thermometer.</li> <li>• Staff remain vigilant for developing symptoms throughout the day</li> <li>• Pupils who are unwell with Covid symptoms will not attend school</li> <li>• Pupils who live with anyone displaying Covid symptoms will not attend</li> </ul>	Students not attending school to be provided with work via, Google Classroom, Zoom Meeting and where necessary in paper form.

Pupil understanding	<ul style="list-style-type: none"> <li>• Pupils know what the main symptoms of Covid are and know to report these if they develop symptoms, no matter how mild</li> <li>• Pupils know to report any suspected family/friend Covid cases to staff</li> <li>• Guidance is displayed around the school</li> <li>• Staff work to encourage pupils to become advocates for disease prevention and control at home, in school, and in their community by talking to others about how to prevent the spread</li> </ul>

Member of a class becoming unwell with COVID-19	<ul style="list-style-type: none"> <li>• If a pupil is awaiting collection, they will be moved to the medical room where they can be isolated behind a closed door and with appropriate adult supervision if required</li> <li>• Ideally, a window should be opened for ventilation. If it is not possible to isolate them, move them to an area which is at least 2 meters away from other people</li> <li>• Suitable rooms have been allocated for this purpose and communicate intentions to staff; SH has been informed</li> <li>• Suitable PPE (including fluid resistant face mask) is available at these locations</li> </ul>	
School Covid test kits	<ul style="list-style-type: none"> <li>• These may be offered in exceptional circumstances if an individual becomes symptomatic and they may have barriers to accessing testing elsewhere</li> </ul>	
Remote learning	<ul style="list-style-type: none"> <li>• If a pupil is self-isolating, remote learning will be provided by the school from the duration of their isolation</li> <li>• Pupils will be provided with remote learning equipment as required</li> </ul>

Travel in staff cars	<ul style="list-style-type: none"> <li>• Each journey will be risk assessed and only journeys which are necessary in order to meet pupil need are approved</li> <li>• Each journey is approved in advanced by the SLT</li> <li>• Pupils and staff must wear face coverings when travelling in vehicles</li> <li>• The windows should be open to the extent that temperature and weather conditions safely allow</li> <li>• Social distancing measures should be maximized, including limiting numbers in vehicles if possible</li> <li>• Hand sanitizer should be used by pupils and staff at the start and end of each journey</li> <li>• Staff are responsible for sanitizing interior and exterior vehicle touch points before and after every journey</li> </ul>

Physical activity in schools	<ul style="list-style-type: none"> <li>• Sports and play equipment will be sanitised before and after use</li> <li>• Social distancing will be maximised</li> </ul>	
Educational visits	<ul style="list-style-type: none"> <li>• All educational visits will be risk assessed and will take into account Covid-19 measures</li> </ul>

Food prepared on premises is compliant with Covid - 19 health and hygiene guidance	<ul style="list-style-type: none"> <li>• All staff involved in the preparation of food, or the teaching of food technology, have had food hygiene training</li> <li>• Staff involved with food preparation will comply with the relevant hygiene related information within <a href="#">Guidance for food businesses on coronavirus (COVID-19)</a></li> </ul>	
Communications with parents and others		
Parents, contractors and other staff entering or working in the building	<ul style="list-style-type: none"> <li>• Signs are displayed telling all parents, carers and visitors not to enter the school if they are displaying any symptoms of Covid-19</li> </ul>	
Oversight by directors		
Lack of director oversight during the COVID-19 crisis leads to the school failing to meet statutory requirements	<ul style="list-style-type: none"> <li>• The directors monitor the school's work remotely using the SchoolPod information management system</li> <li>• There are regular phone calls and virtual meetings between SLT and the Directors</li> <li>• The SLT report half termly to the Directors</li> <li>• A Director will visit the school every half term, unless restrictions disallow, to assess the Covid safety of the school</li> </ul>
